ORDINANCE NO. 639 of 2026**

**AN ORDINANCE OF THE COUNCIL OF THE BOROUGH OF WEST PITTSTON,
LUZERNE COUNTY, PENNSYLVANIA, TO AMEND ORDINANCE NO. 630 OF 2024
TO AUTHORIZE COUNCIL TO APPOINT NEW MEMBERS TO THE BOROUGH'S
COMMISSION ON OPIOID MISUSE AND ADDICTION ABATEMENT AND ACCEPT
THE RESIGNATION OF THOSE MEMBERS WHO NO LONGER WISH TO SERVE
ON THE COMMISSION.**

WHEREAS, by Ordinance No. 630 of 2024, the Council of the Borough of West Pittston (the "Council") did create the Commission on Opioid Misuse and Addiction Abatement (the "Commission") to, inter alia, assist the affected citizens and law enforcement agencies of Luzerne County in their battle against illegal drug trafficking, opioid misuse and addiction;


WHEREAS, by the same Ordinance, Council did appoint certain individuals to serve on the Commission; and

WHEREAS, to assure the continued capacity of the Commission to achieve its stated purposes, Council now wishes to amend Ordinance No. 630 of 2024 to authorize Council to appoint new members to the Commission and accept the resignation of members who no longer wish to serve in such capacity.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED BY THE WEST PITTSTON BOROUGH COUNCIL, the Council of the Borough of West Pittston shall hereby be authorized to appoint new members to the Commission on Opioid Misuse and Addiction Abatement, and to accept the resignation of those who no longer wish to serve on the Commission.

All remaining provisions of Ordinance No. 630 of 2024 are incorporated herein by reference, and fully ratified hereby.


