

ORDINANCE No. 61 of 2026

**AN ORDINANCE OF THE BOROUGH OF WEST PITTSTON**  
**AMENDING CHAPTER 164 (VEHICLES AND TRAFFIC)**  
**SECTIONS 164-21 AND 164-23 OF THE CODE OF THE**  
**BOROUGH OF WEST PITTSTON**

**BE IT ENACTED AND ORDAINED** and it is hereby enacted and ordained by the Borough of West Pittston (“the Borough”) as follows:

**I. Amendments of Sections 164-21 (Parking prohibited at all times) and 164-23 (Time Limit Parking).**

Chapter 164, Sections 164-21 of the Borough’s Vehicles and Traffic Ordinance (the “Ordinance”) specifically dealing with Parking prohibited at all times shall be amended as follows:

- A. Parking shall be prohibited on the northeast side of the 600 Block of Luzerne Avenue in front of what is presently Revelation Lifestyle & Mobility Center, 602 Luzerne Avenue, West Pittston, Pennsylvania a distance of 20 feet to the crosswalk at the northeast corner of Luzerne Avenue and Fremont Street. Signs shall be erected in the applicable areas.**

Chapter 164, Sections 164-23 of the Ordinance specifically dealing with Time Limit Parking shall be amended as follows:

- B. Parking shall be limited to fifteen minutes between the hours of 8AM to 6PM, except on Sundays, on the northeast side of the 600 Block of Luzerne Avenue in front of what is presently Crest Quality Cleaners, 602 Luzerne Avenue, West Pittston, Pennsylvania, and part of what is presently Revelation Lifestyle & Mobility Center, 600 Luzerne Avenue, West Pittston, Pennsylvania a distance of 44 feet. Signs shall be erected in the applicable areas.**

**II. Saving Clause**

All other provisions of Chapter 164 of the Code of the Borough of West Pittston including, but not limited to, all other provisions of Sections 164-21 and 164-23 shall remain in full force and effect, except to the extent specifically amended herein.

**III. Repealer**

All Ordinances or Resolutions or parts of Ordinances or Resolutions not consistent with this Ordinance are hereby repealed insofar as the same affect this Ordinance.

**IV. Severability**

In case any one or more of the provisions of this Ordinance shall for any reason be held to be invalid, illegal, unenforceable in any respect, such invalidity, illegality or unenforceability shall not affect any other provisions, therefore, and this Ordinance shall be construed as if such invalid, illegal, or unenforceable provision has never been contained herein.

**V. Effective Date**

Duly enacted and ordained at a regular meeting of the Borough Council of West Pittston held the 3 day of JUNE, 2026.
