ORDINANCE #613 OF 2018

**ORDINANCE OF THE BOROUGH OF WEST PITTSTON FIXING
THE TAX MILLAGE FOR THE FISCAL YEAR OF 2019**

BE IT ENACTED AND ORDAINED, and it hereby enacted and ordained by the Council of the Borough of West Pittston, as follows:

SECTION I.

That a tax is and the same is hereby levied on all real property within the said Borough subject to taxation for Borough purposes for the fiscal year 2019 as follows:

Tax rate for general Borough purposes, the sum of 3.4301 mills on each dollar of assessed valuation.

SECTION II.

That in addition to the above tax, an additional tax be and the same is hereby levied on all real property within the said Borough subject to taxation for the purposes of paying interest and principal of the indebtedness incurred pursuant to the Act know as the Local Governmental Unit Debt Act, said tax to be levied as follows:

The sum of 0.3999 mills on each dollar of assessed valuation, said tax to be assessed for the fiscal year 2019 and those subsequent years as shall be set forth in specific and express language in the annual ordinance fixing the tax millage.

SECTION III.


That in addition to the above taxes, an additional tax be and the same is hereby levied on all real property within the said Borough subject to taxation for the purposes of the purchase of a fire engine, said tax to be levied as follows:

The sum of 0.2000 mills on each dollar of assessed valuation, said tax to be assessed for the fiscal year 2019 and those subsequent years as shall be set forth in specific and express language in the annual ordinance fixing the tax millage.

SECTION IV.

That any Ordinance or Resolution or parts of Ordinances or Resolutions not consistent with the provisions of this Ordinance are hereby repealed.

**AN ORDINANCE OF THE BOROUGH OF WEST PITTSTON
TREE LAWN PARKING ORDINANCE**

Be it enacted and ordained and it is hereby enacted and ordained By the Borough of West Pittston ("the Borough") as follows:

Section 1 - Definitions

"Tree Lawn" - the untraveled portion of streets lying between the road and sidewalk which abuts on any such property.

Section 2 - Regulations for Parking of Vehicles

1. The parking of any vehicles, including but not limited to recreational vehicles, trailers and recreational vehicles is strictly prohibited on any tree lawn.

Section 3 - Violation and Penalty

Any person, firm or corporation who shall violate any provision of this Part, upon conviction thereof in an action brought before a magisterial district judge in the manner provided for the enforcement of summary offenses under the Pennsylvania Rules of Criminal Procedure, shall be sentenced to pay a fine of not more than \$1,000.00 plus costs and, in default of payment of said fines and costs, to a term of imprisonment not to exceed 90 days. Each day that a violation of this Part continues or each Section of this Part which shall be found to have been violated shall constitute a separate offense.

AN ORDINANCE OF THE BOROUGH OF WEST PITTSTON
AMENDING CHAPTER 164, (VEHICLES AND TRAFFIC)
SECTIONS 164-13 AND 162-21 OF THE CODE OF THE
BOROUGH OF WEST PITTSTON

BE IT ENACTED AND ORDAINED and it is hereby enacted and ordained by the Borough of West Pittston (“the Borough”) as follows:

I. Amendment of Sections 164-13 and 164-21.

Chapter 164, Sections 164-13 and 164-21 of the Borough’s Vehicles and Traffic Ordinance (“the Ordinance”) specifically dealing with one-way streets and prohibited parking shall be amended as follows:

- A. Lacoë Street is restricted to one way traffic from the intersection with Exeter Avenue to the intersection with Linden Street.
- B. Linden Street is restricted to one way traffic from the intersection with Luzerne Avenue to the intersection with Wyoming Avenue.
- C. Race Street is restricted to one way traffic from the intersection with Wyoming Avenue to the intersection with Luzerne Avenue.
- D. Any person who violates any of these provisions shall upon conviction be sentenced to pay a fine of Fifty Dollars (\$50.00) plus costs.

II. Saving Clause

All other provisions of Chapter 164 of the Code of the Borough of West Pittston including, but not limited to, all other provisions of Sections 164-13 and 164-21 shall remain in full force and effect, except to the extent specifically amended herein.

III. Repealer

All Ordinances or Resolutions or parts of Ordinances or Resolutions not consistent with this Ordinance are hereby repealed insofar as the same affect this Ordinance.

IV. Severability

In case any one or more of the provisions of this Ordinance shall for any reason be held to be invalid, illegal, unenforceable in any respect, such invalidity, illegality or unenforceability shall not affect any other provisions, therefore, and this Ordinance shall be construed as if such invalid, illegal, or unenforceable provision has never been contained herein.

AN ORDINANCE OF THE BOROUGH OF WEST PITTSTON
AMENDING CHAPTER 164, (VEHICLES AND TRAFFIC)
SECTIONS 164-44 and 164-51 OF THE CODE OF THE
BOROUGH OF WEST PITTSTON

BE IT ENACTED AND ORDAINED and it is hereby enacted and ordained by the Borough of West Pittston (“the Borough”) as follows:

I. Amendment of Sections 164-44 and 164-51

Chapter 164, Sections 164-44 and 164-51 of the Borough’s Vehicles and Traffic Ordinance (“the Ordinance”) specifically dealing with one-way streets and prohibited parking shall be amended as follows:

A. Susquehanna Avenue is restricted to one way traffic in a northerly direction toward Linden Street with the limits of the one-way restriction extending from the northerly right of way line of Wyoming Avenue north along Susquehanna Avenue approximately 985 feet to the intersection of Linden Street.

II. Saving Clause

All other provisions of Chapter 164 of the Code of the Borough of West Pittston including, but not limited to, all other provisions of Sections 164-44 and 164-51 shall remain in full force and effect, except to the extent specifically amended herein.

III. Repealer

All Ordinances or Resolutions or parts of Ordinances or Resolutions not consistent with this Ordinance are hereby repealed insofar as the same affect this Ordinance.

IV. Severability

In case any one or more of the provisions of this Ordinance shall for any reason be held to be invalid, illegal, unenforceable in any respect, such invalidity, illegality or unenforceability shall not affect any other provisions, therefore, and this Ordinance shall be construed as if such invalid, illegal, or unenforceable provision has never been contained herein.



BE IT ENACTED AND ORDAINED and it is hereby enacted and ordained by the Borough of West Pittston (“the Borough”) as follows:

I. Amendment of Sections 164-13 and 164-21.

Chapter 164, Sections 164-13 and 164-21 of the Borough’s Vehicles and Traffic Ordinance (“the Ordinance”) specifically dealing with one-way streets and prohibited parking shall be amended as follows:

A. Parking along the south side of Wyoming Avenue (State Route 11) from the intersection of Montgomery Avenue to the intersection of Susquehanna Avenue shall be restricted and/ or prohibited.

B. Parking along the north side of Wyoming Avenue (State Route 11) from the intersection of Susquehanna Avenue to the intersection of Montgomery Avenue shall be restricted and/ or prohibited.

C. Any person who violates any of these provisions shall upon conviction be sentenced to pay a fine of Fifty Dollars (\$50.00) plus costs.

II. Saving Clause

All other provisions of Chapter 164 of the Code of the Borough of West Pittston including, but not limited to, all other provisions of Sections 164-13 and 164-21 shall remain in full force and effect, except to the extent specifically amended herein.
