16th ORDER- WEST PITTSTON TOMORROW

Lynn Burbank announced that the next meeting will be April 10th, at 7pm at the West Pittston Borough Building.

17th ORDER-PUBLIC PARTICIPATION

Resident asked for clarification on 3-minute rule, if this meant it was per person per topic

Resident asked if there has been any movement on traffic signal at the Fort Jenkins Bridge intersection. President Quinn responded that this is a county road under jurisdiction of PennDOT and that would be through them. Resident asked what the ARPA money will be used for. President Quinn responded that it was initially a \$11 million ask that was denied and then approved but for \$2 million and when that is finalized, the County will send a request for a project budget and the Borough will make plans then, it will be for stormwater projects. Resident then asked if one of the grants was for Exeter Avenue, President Quinn said that the Borough is still waiting on that, the current grant is for Damon Street. Resident then suggested that the Borough investigates a Light Pollution ordinance.

Resident noted that the Wyoming Area Regional Police Department is doing well and asked Representative Haddock to clarify the Bridge issues.

Representative Haddock spoke on the bridge concern, stating that there is a meeting on Monday to help further clarify the issues between Luzerne County and PennDOT. There was an issue with an underlayment that needs specific attention and that was included in the original report and is part of the safety concern. He also expressed concern and support for the flooding issues and the levee project.

Resident shared concerns about traffic from Fort Jenkins Bridge intersection, he understands that the bridge needs to be closed but the traffic issues caused by it are also dangerous.

John Symmons of West Pittston DPW shared concerns about safety from being understaffed and about a meeting with Union representative and Council. Attorney Bufalino replied that that concern is being actively worked on and all other concerns must go through the Union representative.

Resident shared concerns about holes in Wyoming Avenue. President Quinn responded that that project is still on-going and the holes will be taken care of at the finish of the project.

Chief Pace presented information about the Wyoming Area Regional Police. West Pittston received approximately 100 calls over the last month, with no red flags, some domestics and animal complaints. There have been some concerns with children at the Insalaco shopping center. The police, the businesses, and the property owner are all working together to remedy that issue. The property owner will be paying for a police car to be at the shopping center from 2-6 pm, that will be overtime police hours and will not be coming out of WARP funding or the

Borough. WARP held its first aggressive driving detail to stop vehicles for traffic law violations, which was paid for through state grants. They are also looking at federal funding for additional equipment like vehicles and traffic control signals. Resident asked about pedestrian signage at the Ft Jenkin's intersection, and Bufalino reiterated that that is a PennDOT request. Resident asked if a police car could be stationed there at least during rush hour. Pace said that he will add that to the roll call. Council Member Judge asked Chief Pace if the school is aware of the issues, Pace replied that yes, they are aware and working with the police, he also said that it is a small group of children causing the issues. A resident asked if there was a correlation between the recent bike/scooter thefts and this group of children. Chief Pace said that they are taking that all into consideration, but the Police cannot take action unless those thefts are followed through with pressing charges or getting involved. Resident thanked Chief Pace for getting involved and taking care of this matter.
