ORDNANCE NO. 621

AN ORDINANCE OF THE BOROUGH OF WEST PITTSTON AMENDING CHAPTER 110, (PARKS AND RECREATION FACILITIES) SECTION 110-3 OF THE CODE OF THE BOROUGH OF WEST PITTSTON

BE IT ENACTED AND ORDAIINED and it is hereby enacted and ordained by the Borough of West Pittston that the following section of Chapter 110 of the Code of the Borough of West Pittston ('the Code") is amended as follows:

I. Amendment of Section 110-3.

The following shall be added as provision 110-3(y):

The wheelchair swing shall only be used by individuals who utilize or rely upon a wheelchair for ambulatory or mobility purposes and shall be limited to one wheelchair user at a time.

II. Saving Clause.

All other provisions of Chapter 25 of the Code of the Borough of West Pittston including, but not limited to, all other provisions of Sections 164-21 and 164-49 shall remain in full force and effect, except to the extent specifically amended herein.

III. Repealer.

All Ordinances or Resolutions or parts of Ordinances or Resolutions not consistent with this Ordinance are hereby repealed insofar as the same affect this Ordinance.

IV. Severability.

In case any one or more of the provisions of this Ordinance shall for any reason be held to be invalid, illegal, unenforceable in any respect, such invalidity, illegality or unenforceability shall not affect any other provisions, therefore, and dlis Ordinance shall be construed as if such invalid, illegal, or unenforceable provision has never been contained herein.

V. Effective Date.

This Ordinance Amendment shall take effect upon adoption and publication according to law.
