

AN ORDINANCE OF THE BOROUGH OF WEST PITTSTON AMENDING THE FOLLOWING SECTIONS OF THE CODE OF THE BOROUGH OF WEST PITTSTON SECTION 149.21 CHANGING THE PERMANENT PAVEMENT RESTORATION FEE SCHEDULE, SECTION 58-5 SETTING/CHANGING THE CONTRACTOR REGISTRATION FEE, SECTIONS 136-5 (A) CHANGING THE SEWER TAPPAGE FEE/CONNECTION FEE, SECTION 170-78 B(2), B(3), B(4) CHANGING THE ZONING FEES FOR PERMITS FOR SPECIAL USES, VARIANCES, APPEALS AND AMENDMENTS AND AMENDING THE CHARGE FOR A HEALTH LICENSE.

The Council of the Borough of West Pittston enacts and ordains as follows:

It is the intention of this Ordinance to amend certain presently existing sections of the Code of the Borough of West Pittston and any applicable ordinances or resolutions only to the extent of the provisions hereinafter set forth in order to change certain fees.

**ARTICLE I PERMANENT PAVEMENT RESTORATION FEES**

Section 149-21 of the Code of the Borough of West Pittston shall be amended to read as follows:

Permanent Pavement Restoration Fee Schedule:

\$5.00 Fee per square foot or part thereof for any size pave cut with a minimum charge of \$75.00.

**ARTICLE II CONTRACTOR REGISTRATION FEES**

Section 58-5 of the Code of the Borough of West Pittston shall be amended to read as follows:

At the time of application of a new registration or for the renewal of a current registration, the applicant shall pay the municipality a registration fee of \$100.00.

**ARTICLE III SEWER TAPPAGE/CONNECTION FEE**

Section 136-5(A) of the Code of the Borough of West Pittston shall be amended to read as follows:

- A. The tappage fee or charge for connection with any such sewer or any branch thereof to be paid to the Borough Engineer or Street Commissioner before he shall issue any such permit shall be \$400.00 for all connections.

**ARTICLE IV ZONING FILING FEES**

Section 170-78 (B) (2) (3) and (4) of the Code of the Borough of West Pittston shall be amended as follows:

**170-78 (B) (2):**

(2) Zoning permits for special uses. Uses requiring Board action: four hundred dollars (\$400.00) for business or commercial or uses or two hundred (\$200.00) for residential applicants or uses plus one-half (1/2) of the costs of an appearance fee for a stenographer. The costs of the original transcript shall be paid by the Board if the transcript is ordered by the Board or shall be paid by the person appealing from the decision of the Board if such appeal is made, and in either event the costs of additional copies shall be paid by the person requesting such copy or copies. In other cases the party requesting the original transcript shall bear the costs thereof.

**170-78 (B) (3):**

(3) Variance or appeal application: four hundred dollars (\$400.00) for business or commercial applicants or uses or two hundred (\$200.00) for residential applicants or uses plus one-half (1/2) of the costs of an appearance fee for a stenographer. The costs of the original transcript shall be paid by the Board if the transcript is ordered by the Board or shall be paid by the person appealing from the decision of the Board if such appeal is made and in either event the costs of additional copies shall be paid by the person requesting such copy or copies. In other cases the party requesting the original transcript shall bear the costs thereof.

**170-78 (B) (4):**

Request for amendment: four hundred dollars (\$400.00) for business or commercial applicants or uses or two hundred (\$200.00) for residential applicants or uses plus one-half (1/2) of the costs of an appearance fee for a stenographer. The costs of the original transcript shall be paid by the Board if the transcript is ordered by the person appealing from the decision of the Board if such appeal is made, and in either event the costs of additional copies shall be paid by the person requesting such copy or copies. In other cases the party requesting the original transcript shall bear the cost thereof.

**ARTICLE V HEALTH LICENSE FEES**

The fee charged for issuance of a Health License shall be \$100.00 per year and any applicable Ordinance or Code provisions or resolutions shall hereby be amended.
